


Zion Lutheran Church January 21, 2024 2024 Annual Minutes

The Annual Meeting of Zion Lutheran Church was called to order by Council President Steven Rust at 12:27pm on January 21, 2024. A total of 21 members signed the attendance roster, which was certified as a quorum. Pastor Lee led the group in devotions. The minutes from the prior year's meeting were reviewed. Sue Kipp made one correction to change LeAnn Driggs to Leanna Driggs in the old business section. Benny Bennight moved to approve the prior year minutes as corrected. Nathaniel Grote seconded the motion, and it carried.

Pastor Lee presented his annual report, which includes the parochial report. Pastor Lee reminded the congregation that we *are* the church, we don't just go to church. There were no changes in membership in 2023. Pastor Lee reported that his health is improving, and he thanked the congregation for their patience and understanding. Community outreach is an area of strength for Zion, thanks to members' involvement in the food pantry, vacation bible school, and youth events such as confirmation camp and the youth gathering. Prayer is an area that we have improved on. Improvement can still be made in the areas of studying scripture and parishwide events.

Steven Rust presented the report for the congregational council. He thanked everyone who has contributed to the church in any way.

Dennis Keesee, treasurer, presented the treasurer's report for 2023. He noted that the Luther League account includes some funds from Emmanuel. These are being kept in one account for ELCA Youth Gathering expenses. The congregational council audits all bank accounts, including the Luther League account, monthly. Benny Bennight moved, seconded by Marci Rust, to approve the Pastor's report, the congregational council report, and the treasurer's report. Motion carried.

Committee reports were given for Educational Ministry, Property, Trust Fund, and Worship & Music. The Property Committee could potentially be looking into options for cooling/heating systems in the kitchen and fellowship hall in the next year. Thank you to all who serve on these committees.

Reports were reviewed from the following affiliated organizations: WELCA, Disciples of the Plains (DOTP) Parish Council, DOTP Parish Treasurer and 2024 Budget, Zion 2024 Budget, and Phillips County Ministerial Alliance. On the Zion proposed budget, secretary expense was increased by \$1,440 to cover expenses charged by Emmanuel for using their secretary. Old Business – The Living Lutheran print magazine has been discontinued and transitioned to an online version. The group designated to research new carpet in the sanctuary contacted Kelly Link in January 2023, and he put Zion on his list, but estimated it would be about two years before he could install carpet. An outlet for the Clavinova will have to be installed prior to carpet installation.

New Business

Karin Patton made a motion to cast a unanimous ballot to elect Christina Driggs and Shellie Lare (second term) as congregational council members. Marci Rust seconded the motion, and it carried.

Dennis Keesee made a motion to elect Doug Zillinger as the at-large representative for Zion on the Parish Council. Andrea Keesee seconded the motion, and it carried.

Nathaniel Grote and Kadence Grote volunteered to represent Zion at the 2024 Synod Assembly, June 6-8 in Olathe. Sue Kipp made a motion to approve them as representatives. Howard King seconded, and the motion carried.

Nathaniel Grote made a motion to approve Resolution No. 1 – Adoption of Proposed Financial Goal. Sue Kipp seconded the motion, and it carried.

Benny Bennight made a motion to adopt the required constitutional amendments per the latest ELCA model constitution. Janet McCall seconded. Motion carried.

Benny Bennight made a motion to adopt other constitutional amendments. Dennis Keesee seconded. Motion carried with a majority vote. These amendments will be voted on again at the 2025 annual meeting and must be approved by a two-thirds majority.

Janet McCall made a motion to adopt the amendments to Zion's bylaws. Andrea Keesee seconded. Motion carried. There are no amendments to Zion's continuing resolutions this year.

Other Business: Benny Bennight suggested the congregational council look into an Errors & Omissions insurance policy to protect the church if a council member, pastor, etc. is sued.

Benny Bennight made a motion to approve Resolution No. 2 – Thanksgiving. Janet McCall seconded. The motion passed unanimously with a round of applause.

Benny Bennight made a motion to adjourn the annual meeting. Nathaniel Grote seconded, and the motion carried. The meeting was adjourned with The Lord's Prayer.

ZION LUTHERAN CHURCH TRUST FUND 2024 ANNUAL REPORT

Dear Members of Zion,

I am pleased to present to you the 2024 Annual Report for the Zion Lutheran Church Trust Fund. This past year has been a successful one for the trust, and I am grateful to have had the opportunity to serve on the committee alongside Dennis Deschner, Christina Dettmer, and Dennis Keesee, with guidance from Pastor Lee who served as a non-voting member and advisor.

Throughout the year, our committee convened regularly to review grant applications and assess the financial status of the trust. I am delighted to report that the Trust Fund experienced a positive return of +3.05%, a testament to the effective management and investment of assets by First National Bank and Trust, especially in the face of the challenging economic climate.

In terms of financial performance, the Trust Fund had a carryover balance of \$6,797 from 2023 and distributed a substantial \$9,788 in 2024, leaving the Trust Fund with \$16,151 to allocate towards 2024 projects. After accounting for project expenses, the remaining balance of \$5,651 will be carried over to FY 2025.

In 2024, the committee approved the following grants:

- Zion College scholarships (4 students) \$4,800
- Lutheran Disaster Response (Hurricane) \$1,000
- Oaks Indian Mission (- \$1,000
- Sanctuary Carpet (\$3,200)
- Phillips County Food Bank \$1,000

Total: \$11,000

We are proud to have been able to support these worthy causes and extend our sincere thanks to the members of Zion for their continued support.

Looking ahead, we remain committed to our mission of stewardship and service, and we are optimistic about the future of the Trust Fund. I would like to express my gratitude to everyone involved in making the past year a success and look forward to another year of meaningful contributions and positive impact.
